- **Big Easy Express (BEE):** At the Whittle on 24<sup>th</sup> May, tickets \$10 +HST and TicketPro fees. James Skinner will manage all activities at the theatre. Poster prepared by Steven Slipp.
  - **Action Item: Francois** to notify Paul Callaghan to ensure Paul is aware of all ticketing activities by DRMC.
  - **Concert:** Poster to be distributed alongside BEE poster with hand drawn "Sold Out". Francois will organize ushers with Raca Marinkovic.
    - **Action Item: Francois** to itemize expenses for Leslie.
